*Bylaws, Article II, Sections 3 and 4, read, in part, "No Member may vote whose dues are not paid for the current fiscal year. ... The Board shall annually review the amount of dues for the upcoming fiscal year [payable on or before May 1st]. ... During the month of March, the Recording Secretary shall send to each Member a statement of dues for the next fiscal year. ... A membership will be considered lapsed and automatically terminated ... if such member's dues remain unpaid after June 30th."*

*In February, the Board decided to keep dues at the current level; therefore, the dues for a Regular Individual Member are \$20. Lifetime, Junior, and Honorary members need not pay dues.*

*Standing Rule 9. reads, in part, "An applicant accepted into membership after January 1st will be considered paid through the following club fiscal year."*
