
**PLANNING YOUR APPOINTMENT TIME:** *A dog's pupils start constricting again within 2-3 hours after drops so dogs with later ring times could be examined first thing in the morning. Pupil dilation does not affect the vision in dogs like it does humans because they do not accommodate (use the muscle in the iris to fine focus their vision). It can make some dogs a little light sensitive until the pupil can constrict some which is more of concern at outdoor shows on sunny days.*



The following breeds must be judged on a Ramp through all levels of conformation competition: Lagotto Romagnolo, Clumber Spaniels, English Springer Spaniels, Sussex Spaniels, Basset Hounds, Cirnechi dell'Etna, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden, Spanish Water Dogs. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. The full policy and list of Table and Ramp eligible/required breeds is available on the AKC website at:

Judges may request the ramp to judge any breed in emergency situations; if granted, unless the use of a ramp has been indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. Junior Showmanship judges should follow the above.


